**Where is  
SHALVA located?**

Due to the nature of SHALVA's domestic violence work, the State of Illinois requires that the location be confidential to protect our clients and staff.

**Are you a shelter?**

SHALVA is not a shelter, but we have access to emergency housing and collaborate with domestic violence shelters to provide kosher food and Jewish information.

**What exactly does  
SHALVA do?**

SHALVA responds to domestic violence in the Chicago Jewish community; we provide free individual and group counseling, legal information, court support, interest free loans, 24 hour help-line, prevention/education programming.

**How are you funded?**

SHALVA is funded by individual, corporate and foundation donors and receives a special grant from the Jewish Federation of Metropolitan Chicago.

### Diane L. Rosenfeld is a Lecturer on Law at Harvard Law School

where she teaches Gender Violence, Law and Social Justice and supervises clinical students who work on women's rights legal advocacy and gender justice.

Additionally, she teaches reading groups on Feminist Jurisprudence; Power, Beauty, Sex and Violence; and Theories of Violence: Gender and Sexuality. She taught at Harvard College for four years previous to that as a Lecturer on Women's Studies. Prior to teaching at Harvard, Ms. Rosenfeld served as the Senior Counsel to the Violence Against Women Office of the U.S. Department of Justice and as an Executive Assistant Attorney General in Illinois where she provided legal policy advising in women's rights, environmental enforcement, and the ethics of government attorneys.

Ms. Rosenfeld co-produced, with Cambridge Documentary Films, "Rape Is..." which has received several film awards ([www.rapeis.org](http://www.rapeis.org)). She has lectured extensively with the film around the country and abroad. Ms. Rosenfeld is a frequent public speaker on the various legal and social policy issues concerning violence against women. She currently serves as a Commissioner on the Governor's Commission on Sexual and Domestic Violence in Massachusetts.

In 2005, she was awarded the Champion for Change Award from the Boston Area Rape Crisis Center.

### Domestic violence monitoring initiative proposed by Rosenfeld is signed into law

Domestic abusers who violate their restraining orders will be required to wear a GPS tracking device, according to a new Massachusetts state law spearheaded by HLS lecturer Diane Rosenfeld '96. Signed into law on January 4, the GPS initiative was first presented to the Governor's Commission on Sexual and Domestic Violence by Rosenfeld in early 2005.

Under the new law, if a domestic abuser enters a geographic "exclusion zone"—a court-determined restricted area, such as a victim's home or workplace, or a child's school—the GPS device will immediately alert both the domestic abuse victim and the police. According to existing Massachusetts law, any individual who violates his restraining order is eligible for a \$5,000 fine and a prison sentence of more than two years.

Rosenfeld has also championed legislation that would create a universal danger assessment program, allowing police departments to screen every domestic abuse situation for "lethality factors"—common warning signs gathered from domestic homicide cases over the past 25 years.

Rosenfeld emphasized that the goal of the GPS law is to prevent future violence, while allowing battered women to stay in their homes and their communities without fear. "This legislation puts the responsibility for battering where it belongs—on the offender," she said.

Former Lieutenant Governor Kerry Healey, who chaired the Governor's Commission on Sexual and Domestic Violence, called the GPS bill a longtime personal priority. Many victims of domestic violence continue to be abused even after they have obtained restraining orders against their batterers, Healey said. The victims are often forced into hiding, fleeing their jobs, their homes and their families. - *Harvard Law School*

# SHALVA Provides Outreach Education At Loyola University Hillel

In the spirit of SHALVA's continued efforts to provide preventative education to the Jewish community, Outreach Educator, Debbie Korman, recently met with Loyola University Hillel students to discuss healthy relationships.

## Areas covered during the program were:

- What is domestic abuse?
- Why does domestic abuse happen?
- Why people stay in abusive relationships?
- How to leave an abusive relationship safely?

Educating young adults about healthy and unhealthy relationships provides them with the understanding and tools to have happy and successful relationships.

Male and female students engaged in a serious conversation about these issues and how they affect people they know, including college students their own age.
